

# INFORMATION MEASURES TO PREVENT CONTAGION FROM SARS-COV-2 VIRUS FOR PARTICIPANTS IN EVENTS

#### **GENERAL PRINCIPLES**

The prevention of the spread of sars-Cov-2 virus infection is a priority for **SKAL Club of Rome** and for the entire supply chain of professionals and companies operating in the tourism and meeting industry.

To ensure the safety of speakers, participants, sponsors, technical staff and supportstaff, **SKAL Roma** applies in the organization of each of its events in the presence of thehygienic-sanitary and behavioral measures provided for by the "Guidelines for the reopening of Economic, Productive and Recreational Activities" issued by the Conference of Regions and Autonomous Provinces in compliance with the Decrees of the Presidency of the Council of Ministers on the organization of conferences and aggregative events in biological safety (Covid-19 Virus)

This information aims to sensitize all participants to compliance with the hygienic-sanitary measures recommended by the Health Authorities.

All participants must be adequately informed about the correct behaviors to be adopted in a context of potential risk of spreading the contagion such as an aggregative event.

### ENTRY REQUIREMENTS TO THE EVENT

It should be noted that, in compliance with Legislative Decree no. 105 of 23 July 2021 on urgent measures to deal with the epidemiological emergency from Covid-19 with particular reference to art. 3, paragraph 1, access to the event is allowed only to subjects in possession of **Covid-19 Green Certification** (also called Green **Pass)**, issued in accordance with the provisions of Legislative Decree no. 52 of 22 April 2021 (converted with amendments by Law no. 87 of 17 June 2021).

The verification of the aforementioned requirement will be carried out at the accesses of the locations: meeting / catering / hotel / monuments, by delegated personnel using the VerificationC19 application as per the Decree of the President of the Council of 17 June 2021 art. 13 and the Ministry of Health directive of 28 June 2021.

We remind you that this application allows you to ascertain, by reading the QR code shown on the certificate presentable both in electronic and paper format, the validity of the certificate itself making visible to the operator only the name, surname, and date of birth of the holder, whose identity must be confirmed, if deemed necessary, by showing a suitable identity document. Green Certifications issued by other States are allowed only if in compliance with current government regulations. ## SANITARY MEASURES WHOSE OBSERVANCE IS RECOMMENDED

- Always wear a mask indoors

personal data will not be disseminated and may be disclosed to third parties only in the cases and in the manner provided for by current legal provisions (e.g.: reconstruction by the Authority of the supply chain of any close contacts of a subject who has tested positive for COVID-19).

The data will be processed for the time strictly necessary to pursue the aforementioned purpose.
